Sub 1:- Confirmation of minutes of the previous meeting:

Minutes of the previous meeting held on 02 August 2023 were read out by the Secretary for the present members and were passed unanimously.

Sub 2:- To consider and approve syllabi, structure, directions of BSW and MSW programmes as per NEP 2020:

Syllabi, structure and directions as approved by the Board of Studies of the college for BSW and MSW programmes for implementation

from the forthcoming session 2024-2025 were placed before the members. Prof. Shilpa Tibhenkar made detailed presentation of the same explaining multiple entry/exit provisions and choices of subjects offered for students. After due deliberations, it was decided to place the same before the Governing Body for final approval.

Mr. V. G. Nair pointed out the directions issued by R.T.M. Nagpur University regarding alteration in sequence of papers for M.Com (IR & PM) programme. It was unanimously decided to adopt the same with immediate effect after approval from the Governing Body.

Further, Principal Dr. Swati Dharmadhikari placed a detailed proposal to start a 04 months course, 'Diploma in Mastering Media Literacy' with total of 16 credits incorporating 03 certificate levels of one month duration during the course.

After discussing the utility and feasibility of the course, it was decided to approve the same for consideration and approval of the Governing Body.

Sub. 3 : Information on transfer of Social Work Colleges to Department of Higher and Technical Education :

Principal Dr. Swati Dharmadhikari informed the members that the government of Maharashtra, vide Govt. Resolution dated 29^{Feb 2024} has transferred the running of Social Work colleges from Department of Social Welfare and Special Assistance to Department of Higher and Technical Education with immediate effect.

Sub. 4 : To recommend on CHB appointments as per requirement for upcoming session:

Considering increasing teaching workload and inadequate number of regular teachers, the matter of engaging temporary teachers on Clock-Hour-Basis was discussed. The members approved the idea and left the decision to be finalized by the Governing Body.

Sub 5 : Any other matter:

With no subject left on the agenda, the meeting was concluded with vote of thanks proposed by the Secretary to the Chair and present members.
