Agenda 3: To consider and approve amendments in directions for BSW/MSW/MIRPM if any.

As regards entry of outside students from 3rd semester onwards for BSW programme, an amendment was suggested by the Principal to the effect that students from other colleges seeking admission in the college from 3rd semester onwards will be absorbed subject to clearing of field work component in the previous semesters and after adhering to A.T.K.T rules.

Mr. V. G. Nair brought into the

notice of members that RTM Nagpur University, following the NEP guidelines has issued a circular dated 25 July 2023 regarding change in nomenclature of Master in Industrial Relations and Personnel Management (MIRPM) to M.Com (Industrial Relations). It was decided to adopt the changed nomenclature for existing MIRPM course in the college. In addition, the directions, syllabus structure etc. were also adopted according to NEP guidelines. The changed syllabus for the course was presented before the members and was approved for presentation before the Academic Council.

Agenda 4 : To consider the proposal to approve one year Diploma in Business Management (DBM).

Mr. V.G. Nair presented a detailed structure of the newly proposed Diploma in Business Management, a one year diploma programme, consisting course contents, fee structure and examination fee etc. It was accepted for putting before the Academic Council for approval.

Agenda 5 : Holding of implementation of syllabi as per NEP.

Dr. Swati Dharmadhikari apprised the members that though it was decided in the previous meeting to implement NEP based syllabi from the ongoing session, the same was put on hold as the directions regarding same are not ready at the university level and the process for which is going on. She stated

that the revised syllabus shall come into effect once the state level guidelines are formed.

Agenda 6: Any other matter ---

A proposal to start an 'E-Learning course in Media Literacy' was considered during the meeting. However, going by the high fee structure of the course, the proposal was abandoned with a condition that if the incorporating agency comes up with a feasible fee structure, the proposal may be put before the Academic Council for approval.

Further, with no other subject left on agenda, the meeting concluded with vote of thanks to the Chair and present members.
