Proposal from Academic Committee to engage visiting faculties for following subjects was accepted.

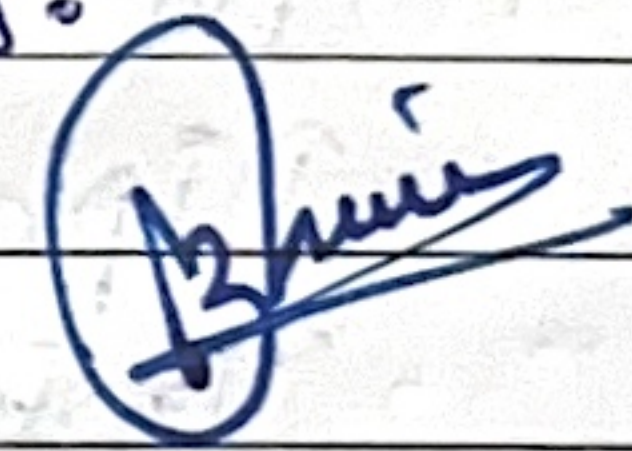
