Agenda 1: Minutes of the previous meeting held on 12 Dec. 2023 were read out by the Principal and were confirmed unanimously.

Agenda 2 : The decision taken in the Academic Council meeting held on 15th April 2024 were put before the members for approval. Structures (Academic Regulations) of the following programmes were approved to be implemented from the forthcoming session 2024-25.

- a) Three/Four Year Honour/Honours with Research Degree Programme Bachelor of Social Work (BSW)
- b) Two Year P.G. Degree Programme in Social Work Master of Social Work (MSW).

It was also decided to approve the course contents of the subject Research Methodology under P.G. degree programme M.Com (I.R and P.M)

Further, it was also decided to start a new diploma-course, 'Diploma in Mastering Media Literacy' from the session 2024-25.

Agenda 3 : Principal Dr. Swati Dharmadhikari informed the members that the government of Maharashtra vide resolution dated 29 February 2024 transferred the social work colleges in the state run by Deptt. of Social Welfare to Deptt. of Higher and Technical Education with immediate effect.

Agenda 4 : The students' fee structure for various programmes run by the college was prepared and recommended

by the Finance Committee of the college in its meeting. The same was tabled before the members and was approved by the members to be implemented from the session 2024-25.
